#### Sub: NUSI Triennial General Body Meeting

The Triennial General Body meeting of National Union of Seafarers of India (NUSI) was held on 12<sup>th</sup> May, 2018 at 10.30 a.m. at Kesar baug Hall, 2nd Principal Shaikh Hasan Marg, Off. Shaida Marg, Hazrat Iman Hussain Chowk, Mumbai – 400 009.

Capt. Nand Hiranandani, NUSI - President presided and welcomed all the seafarers assembled at the meeting. General Secretary-cum-Treasurer, Shri Abdulgani Y. Serang presented the report of activities of the union. The following important work done by NUSI was highlighted:

- 1. National Maritime Board (India) (NMB) (I) Agreement




